Withdrawal of consent can be made at anytime by writing to the school.

Image taking by parents, legal guardians or family members

- Parents/legal guardians, family members and friends can take images of their child and friends participating in school activities for family and personal use.
- All parents will be asked for permission to take photographs for use in the school, on the website, on our social media accounts and in associated publications (prospectus, newspaper etc) by completing the attached form. Permission is given/not given once for use in all circumstances
- Parents/legal guardians will sign to agree that any images they take at school events will be limited to personal/family use by completing the attached form: they will agree not to upload these to social media sites
- Photography and video filming will be limited to designated areas.
- Use of cameras and other equipment will be monitored.
- All digital images will be kept in school for data protection reasons.

Images for school publications

- The school will only take and use images that are appropriate and are considered to not be open to misuse.
- If an image of a child is used, the child's name **will not** be published. If a name is published, **no image will be used** without specific consent.
- Children will be made aware of why their picture is being taken and how it will be used.
- Children and parents should be encouraged to recognise the value of photographs or recordings of school events.
- Images will be kept securely and held by the school for the duration of the pupil's time there, or as needed, after which they will be destroyed.
- Images of children from the school will not be used to illustrate controversial subjects.
- Images of children may appear in other children's learning journals ie. paired or group work.

Images for the school website/learning platform

 School websites are part of the internet and are more easily accessible than paper based school publications. The school will make sure that only appropriate images are used. Image filenames will avoid using children's names.

• Unnamed images of children may be used on our social media accounts. These will be appropriate images linked to specific learning activities

Webcams/video conferencing

- Webcams are a useful tool for learning. They can allow an individual or class to interact over the internet with others and support links between pupils in different schools, countries and cultures.
- A webcam will only be used in appropriate circumstances such as a normal class setting.
- Both children and teachers will be made aware of when a webcam is in use.

CCTV

- The school may use CCTV in some areas of school property as a security measure.
- Cameras will only be used in appropriate areas and there will be/is clear signage indicating where it is in operation.

Children photographing one another

- Staff will supervise and maintain control over any photographing pupils do during on-school activities.
- Pupils should ask permission before taking a photograph of another child.
- Mobile phones, including camera phones, should not be used during the school day but should be handed in to the school office.
- If it is found that cameras or camera phones have been misused, the school will follow its usual disciplinary procedures.

Please note that images taken by the media are not covered by this policy and are subject to a separate set of regulations.

There have been rapid changes in the technology of image reproduction. Taking and publishing pictures are now easy and it can be difficult for schools to monitor and control images of children.

If, for any reason during your child's time at the school you wish to withdraw your consent for images to be taken, please inform us as soon as possible.

Policy for Use of Images of Pupils

Key Policy Points

- Billingshurst Primary School recognises that a balance between the low risk of misuse and the numerous positive results of colourful, well produced school material is necessary.
- The school will only take and use images (photographs, videos and DVDs) that are appropriate and are considered to be safe from misuse.
- Children will be made aware of why their pictures are being taken and how they will be used.
- The school will take extra precautions to ensure that only appropriate images are used for the website.
- If it is found that a camera phone has been misused the school will follow its usual disciplinary procedures.
- If an image of a child is used, the child's name will not be published. If a name is published, no image will be used without specific consent.
- Parents and legal guardians will be asked to sign an agreement that any images they take during school activities will not be used inappropriately.
- Withdrawal of consent can be made at anytime by writing to the school.
